Basic Services of Funeral Director and Staff\$2,580.00

Our fee for the basic services of funeral director and staff includes, but is not limited to, the following: respond to initial request for service; arrangement meeting with family or responsible party; consultation with family and clergy; arrangement of funeral; preparation and filing of necessary notices, authorizations and consents; coordination of this with arrangements selected. Also included in this charge are overhead expenses relative to our facility such as insurance, maintenance and utility expenses, administrative costs, equipment and inventory expenses.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials and forwarding or receiving remains.)

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Michigan law requires embalming when death was caused by certain infectious diseases or, with very limited exceptions, when the body is not taken to its final destination (such as a cemetery or crematory) within 48 hours since the time of death.

It does *not* include the use of facilities or staff for any viewing, visitation or ceremonies, public or private, or attendant rites prior to forwarding the remains or common carrier charges.

This charge includes removal and shelter of the remains, necessary basic services of funeral director and staff, obtaining required authorizations and local transportation (within 30 mile radius) to cemetery. It does *not* include the use of facilities or staff for any viewing, visitation or ceremonies, public or private, or attendant rites, the actual cost of the grave at the cemetery, the cemetery's charges for opening and closing the grave, the preparation of the grave site, or any other goods or services except those expressly set out above.

Cremations:

This charge includes removal and shelter of the remains, necessary basic services of funeral director and staff, obtaining required authorizations and local transportation (within 30 mile radius) to crematory. It does *not* include the use of facilities or staff for any viewing, visitation or ceremonies, public or private, or attendant rites, the actual cost of the cremation process, or any other goods or services except those expressly set out above.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are wood and cardboard.
